The county approved next years budget with an approximate 2% increase. They city may be vacating some of the office space in the courthouse that the county will reallocate to other departments that are growing. The county is working through a business continuity plan in case of a disaster/emergency. They are using the opportunity to also look for daily operational efficiency. The county approved a tentative consent agreement regarding the mobile home park sale.

Roy Thelen, DAESA -

32 runs in October, 8 were in Riley Township. The auditor reviewed the authority's finances and it is in good shape. The authority is currently debt free. The Fire Prevention open house was well attended. The command staff is looking into an emergency management coordinator. They would be responsible for plans in the event of local emergencies or disasters.

Randy Whitney, Planning Commission – Nothing to report at this time

OLD BUSINESS:

BS&A Software has the ability for local jurisdictions to host their tax records on their website so people have real time access to our tax records.
