NEW BUSINESS:

The communication from the Drain Commissioners office was reviewed. The Road Commission is anticipating completion of Lowell Road the week after Labor Day, although there may be a delay due to trucking of gravel. Brush spray has been completed throughout the township. The cemetery is near completion, although it needs to be gone over with a rake for leveling/smoothing. It will be seeded yet this fall, as there is plenty of moisture in the ground to support good growth. Don will work with County to see if we need a special use permit to open the cemetery. Don is working on ordinances, rules, and regulations for the board to review. Supervisor Chant received a bid from a builder to construct a pavilion at the township hall, 28X40. Breakdown includes \$10,000 for the pavilion, \$3500 for concrete through Pung Foundation, Inc. and \$2000 from Don Theis for sand and preparation. There was discussion about what would need to be included and the possibility to prepare a package for bidding purposes. A small group will research the current structure at Motz Park and look at options for future construction and bring information back to the October board meeting.
