- Lawn Care motion by Martens, support by Feldpausch to select Cole's Lawn and Landscaping as the 2025 bid award winner. Motion carried. Clerk Powell will contact the bidder to secure a copy of insurance and review expectations.
- Township website Pam shared a proposal of what could be included on the new website. She will move
 forward with companies that would be able to assist us in meeting the new compliance standards.
 More information will be provided at the May meeting.
