**CALL TO ORDER:**

**PUBLIC COMMENT ON NON-AGENDA ITEMS**

Robert Eaton came to the board to discuss a possible land division. He has been referred to Doug Riley and Pete Preston to understand the process and get assistance with aligning to current zoning ordinances.

**RECOGNITION OF GUESTS:**

Deputy Rennekar – overall it has continued to be quiet, be aware of the deer that are moving. Fraud continues to be an issue as well, if you feel that you have been targeted, please reach out to the Sheriffs office. Sheriff Sean Dush was also in attendance and provided an introduction and background.

Commissioner Pohl – the county approved the Veterans Affairs contract. If there are Veterans who have needs, they should connect with the county (contracted through Ingham County, come to Clinton at least 2 days per week). They did renew the extension contract at a cost savings over prior years. There was a partial collapse at the road commission project, luckily no one was injured, and it has been repaired. Budget discussions continue in preparation for the public hearing. The study for the broadband project has been completed. RFPs have been distributed to several interested parties.

**OLD BUSINESS:**

Spraying of the Feazel drain has been completed .

Multiple departments continue to work to collaborate on all necessary steps to finalize removal of this.

**NEW BUSINESS:**

The rental contract still speaks to a partial day rental and has become an issue for people who are looking to add a half day prior to their full day rental. Motion by Martens, support by Feldpausch to remove this language and move to solely full day rentals. If residents wish to have additional days, they can do so for a full day at the regular rate. Motion carried.
